- Recognizing the challenges and benefits of welcoming internationally trained healthcare professionals into the workforce, we expanded our collaboration with the Department of Post-Secondary Education, Training, and Labour.
 Together, we are working to streamline pathways for internationally trained healthcare workers to contribute their skills effectively within the province.
- In an effort to increase member benefits, NBART has established a partnership with Higgins Insurance. This collaboration provides NBART members with access to exclusive insurance benefits, proving our commitment to supporting our members both professionally and personally. We are also excited to announce a \$1000 scholarship that will be available to NBART members and families beginning in 2025. We will share details on the application process in the New Year.
- These achievements underscore NBART's dedication to respiratory therapy practice in New Brunswick. We look forward to building on this momentum in the coming year to further support our members and the communities they serve.


